

## TERRAPIN TRADER SURPLUS PROPERTY CLEANING CERTIFICATION

*Instructions: Prior to acceptance of surplus laboratory equipment, Terrapin Trader requires that the originating department certify that reasonable means have been taken to clean the equipment before it is offered for sale or disposed. The department Supervisor/Director or Principal Investigator/Chair must answer the following questions, sign and submit this form to the Terrapin Trader staff when the equipment is picked-up.*
